Dear RO Representatives,

We have had numerous queries from our RO's in respect to the issue of electronic certification.

Please find this email as confirmation of in principle authorisation for all AMSA RO's to issue electronic statutory certification on behalf of the Australian Maritime Safety Authority under the provisions of the Navigation Act 2012.

This agreement is limited to those Statutory E-Certificates as detailed in IMO "List of Certificates and Documents required to be carried on board ships 2017" issued vide FAL.2/Circ.131, MEPC.1/Circ.873, MSC.1/Circ.1586, LEG.2/Circ.3 dated 19 July 2017, as amended, and for which are authorised to RINA within the AMSA RO Agreement.

The electronic certificates must include, as a minimum, the security features as detailed in IMO "Guidelines for the use of Electronic Certificates" (FAL.5/Circ.39/Rev.2)

Vessel owners and operators of Australian registered vessels who intend to carry and use electronic certificates are required to ensure that these certificates are controlled through the Safety Management System, as described in section 11 pertaining to Documentation control within the ISM Code.

Official agreement will be made via forthcoming amendment to the AMSA Instructions to Class (ITC) and the RO Agreement.

Could you please provide confirmation of receipt of this email and acceptance of that above to <a href="mailto:fsc@amsa.gov.au">fsc@amsa.gov.au</a> for our records by 9<sup>th</sup> November 2018.

This confirmation may have been received by some parties in this email previously; however it appears that due to some changes in RO representatives of late, previous correspondence may not have been received to all RO's.
