As one of your Recognized Organization(RO), this classification Society, Korean Register of Shipping (KR), would like to convey our sincere appreciation for your esteemed Administration's dedicated efforts to enhance maritime safety and protect marine environment.

BACKGROUND

The IMO FAL Committee recently approved the attached IMO guideline FAL.5/Circ.39/Rev.2, the "Guidelines for the Use of Electronic Certificates". The guidelines are intended to alleviate the problems inherent in paper documentation and facilitate the maritime sector's move toward the use and acceptance of electronic certificates.

In order to respond such a trend, some of administrations already established and provided their own instructions for use of electronic certificates and ROs are encouraged to develop capabilities to issue the electronic certificates in accordance with the FAL.5/Circ.39/Rev.2 to their ships.

REQUEST TO YOUR ADMINISTRATION

We would like to inform you that KR have established our system for issuing electronic certificates which is in compliance with IMO guideline FAL.5/Circ.39/Rev.2. (Please refer to attached sample e-Certificate and User Guideline)
