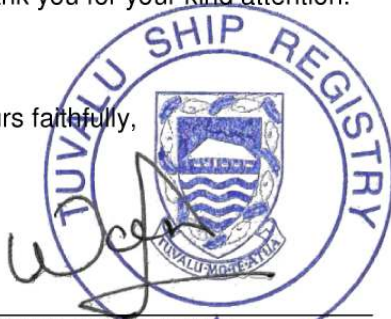
RE: ACCEPTANCE OF ELECTRONIC CERTIFICATES

SUBJECT: GUIDANCE TO RECOGNIZED ORGANIZATIONS ON THE ISSUANCE OF CERTIFICATES ON BEHALF OF TUVALU

DEFINITIONS:

The following abbreviations stand for:

- "IGS" – Inert Gas System
- "RO" – Recognized Organization as defined by IMO Resolution A.789(19).
- "RO-DOC" – May include Statutory Certificates, Forms, Survey Reports etc. issued by the RO on behalf of Tuvalu.
- "SOLAS" – International Convention for the Safety of Life at Sea (SOLAS), 1974, as amended
- "TPA" – Thermal Protective Aid

The term "Administration" shall mean the Tuvalu Ship Registry.

PURPOSE:

This Marine Circular serves as a supplement to the agreements between the Recognized Organizations (ROs) and Tuvalu and provides guidance to the ROs on the issuance of statutory/exemption certificates and forms.

CONTENTS:

1. Guidance on Distinctive Numbers of Letters

- 1.1. The use of official numbers in the "Distinctive Number or Letters" field of statutory/exemption certificates and forms may cause inconvenience when vessels change owners/charterers as the Official Number changes when the registered owner/charterers change thus requiring the RO certificates/forms to be re-issued. However, the Call Sign remains the same during such changes.
- 1.2. This Administration hereby mandates that the vessel's Call Sign be used, instead of its Official Number, on all RO certificates/forms, issued under the authority of Tuvalu, that have a field for "Distinctive Number or Letters".
- 1.3. ROs may however use the Official Number in the field for "Distinctive Number or Letters" when vessels are not issued with a Call Sign.

2. Submission of Copy of Statutory Certificates/Forms/Survey Reports

- 2.1. ROs must provide this Administration with at least one (1) copy of every Statutory Certificate/Form/Survey Report (RO-DOC) issued. This Administration accepts the submission of any RO-DOC in electronic format provided the electronic format complies to FAL.5/Circ.39/Rev.2.
- 2.2. For ROs who require this Administration to access the RO's online database in order to obtain an electronic RO-DOC, then the RO is expected to notify this Administration whenever a RO-DOC is issued or reissued.
- 2.3. All notifications from ROs with regards to submission of any type of RO-DOC shall be made to: technical@tvship.com, or if submission by hard copy then to be addressed to the address as noted in the letterhead of this marine circular.

3. Guidance on Exemption Certificates

- 3.1. ROs are authorized to issue any required interim or full term Exemption Certificate for use with the appropriate RO-DOC. A copy of the Exemption Certificate must be provided to this Administration in accordance to Section 2 of this marine circular.
- 3.2. Except for the provisions of sub-section 3.5 of this marine circular, all requests for exemptions must be approved by this Administration.
- 3.3. Exemption requests proposed to this Administration prior to vessel's delivery shall be accompanied by evidence that the Ship Owner / Operator has been consulted on the matter and is in agreement with the request.
- 3.4. ROs may reissue an Exemption Certificate during a Renewal Survey after verifying that the conditions for its issuance are still satisfied.
- 3.5. The SOLAS Convention contains provisions for exemptions where the qualifying factors for granting the exemption are clearly specified in the applicable SOLAS regulation. As such, this Administration has no objection that the initial Exemption Certificates corresponding to the following exemptions be issued by a RO without prior approval on condition that the specified qualifying factors have been satisfactorily verified:
 - 3.5.1. certain tankers of less than 40,000 deadweight tons from the requirement to be fitted with an IGS;
 - 3.5.2. vessels other than bulk carriers, as defined in SOLAS Chap IX Reg 1, that are constantly engaged on voyages in warm climates, defined to be those within the zone between 30 degrees North latitude and 30 degrees South latitude, from the requirement to carry immersion suits and/or TPAs; and
 - 3.5.3. vessels that carry only ore, coal, grain, unseasoned lumber, non-combustible cargoes, or low fire risk cargoes, such as those mentioned in MSC.1/Circ.1395, from the requirement to be fitted with a cargo hold fixed fire extinguishing system.
